**PLEASE READ THE CONTRACT CAREFULLY, IN CASE OF DOUBTS DON'T HESITATE TO ASK, THANKS!**

- As the new owner of the aforementioned animal, you undertake to keep it in excellent condition, according to healthy zoophilic criteria, as a beloved pet in your home, just as any other member of the family; It must have the freedom to decide where to stay; NO JUST IN THE GARDEN, OR IN A BOX OR IN FIELDS or any other aberrant accommodations, where the dog would feel like living in social isolation (considered mistreatment).
- You are also committed:**
- To carry out all the preventive prophylaxis (worming, vaccines, heartworm, etc.) that the trusted veterinarian deems appropriate and to record them in the appropriate health booklet of the animal's name; You commit also to provide the animal with adequate nutrition and any further care that may be necessary throughout its life;
- To mandatorily provide for the sterilization of the animal, female or male, with the exception of male dogs in case of behavioral or veterinary reasons, certified by professionals (dog trainer expert in behaviour, veterinary behaviourist doctor) to be sent to the entruster.
- Not to pass the pet on to third parties, without the prior consent of the entruster and subsequently notifying the local canine registry.
- To inform the canine registry of any change of domicile and/or residence, or telephone number via your veterinarian.
- To immediately communicate the loss/theft/escape or death of the pet to the canine registry office and to the ArcaDeiCani association.
- To release and indemnify the entruster from any responsibility and consequence that the dog may cause, damage to himself or to third parties, due to lack of custody, or mismanagement, not expected escape due to distraction or failure to manage the pet.
- To show the pet to the entruster or to the staff in charge of it, during occasional home checks (volunteers and/or associations and/or zookeepers and/or local health service).
- To take the dog, in case of behavioral problems, to specialists in the dog sector, such as dog educators, rehabilitation instructors, veterinary behaviourist doctors.

11. To release the dog off the leash only in safe and fenced areas, and only if you have created a relationship whereby you are absolutely sure that the dog will respond to you when you call it off. We recommend GPS for the first few years of living together.
12. To return the pet upon request to the entruster if one of the previous conditions is not respected, without raising any objection (pursuant to and for the purposes of articles 1341 and 1342 of the civil code).
13. ArcaDeiCani is available to help you with the insertion of the dog into your family and in the life journey that you will take together; in case of problems, whether for better or for worse, do not hesitate to contact us quickly, no one will judge or accuse you, but together we will solve any problem.
14. The adopter is therefore obliged to maintain an ongoing relationship with the association, with photos and stories, to share with us the good and bad experiences that our friend will live, because we really love your dog as you do, we saved it and looked after it for a while and we care about it.
15. ArcaDeiCani also reserves the right to take over the dog in case of serious problems that may arise over time, such as serious illnesses or death of the owners, or in the event that the dog risks of being abandoned to itself.
16. Wanting to return the dog is not a justified reason : due to sudden aggression, due to poor management or hyperstimulation, or even worse to not respecting the dog's needs (AS SAID IN POINT 9 THERE ARE PROFESSIONALS TO SOLVE THE PROBLEM), illnesses caused by carelessness or bad luck (SAME POINT 9 TAKE IT TO THE VETERINARIAN), divorce, change of house or job, pregnancies, hypothetical allergies, unforeseen growth (THE SIZE IS HYPOTHETICAL ON PUPPIES) in all these cases and others... if the dog is brought back to the shelter, the adopter must bear the costs of detention, maintenance (food), pesticides and veterinary care until a new adoption, quantified approximately at €150.00 per month; in this case THE DOG HAS TO BE BROUGHT BACK TO OUR SHELTER BY YOU, DO YOU AGREE? YES NO
17. Keep in mind that dogs at the shelter live in boxes and outdoors; this means that they are not educated to do their needs outside the house, you will have to get them used to it, taking them out several times a day, rewarding them and cheering with them when they pee and poop outside, without scolding them or scaring them if they do it indoors, you must have patience and they will learn beyond the age.
18. If the dog is too young, you will have to sterilize him/her as soon as he/she is of the right age, it is forbidden to let him/her have puppies, if the dog is female, it will remain registered to ArcaDeiCani until sterilization has taken place, which you will have to document it for us; in case of necessity, for the change of ownership before sterilization has taken place for various reasons, you will still be obliged to document it to us.
19. The fact that the property will remain to ArcaDeiCani for a period, the possession will still be yours; therefore, you will be in all respects responsible for the dog. This point is specific for dogs to be sterilized or dogs in stable.
20. An offer of €110.00 is required as partial refund of the costs incurred by the association, or €150.00 in the case of dogs that have been sterilized or rescued because they are pure breed.
21. We request refund of travel costs for the possible insertion of the adopted dog in your home, for the presence of other animals or for your inability to come and take it.
22. You must give dogs the right TIME to process the change, you cannot think that in a week it will become the perfect dog; if there are other animals give them time to get to know each other and understand each other through their own communication, you must not intervene unless there are dangers, and you must not force things.

We will not accept threats of return or accusation of not having explained the situation to you in detail, we will be 100% honest in saying the dog's strengths and weaknesses, don't be impatience to see changes, just keep in mind that they have already lived the hell in earth, we entrust them to you so that they are fine and protected.

The changes will arrive if you are competent and overall they will arrive after at least a couple of months; don't expect the dog to change within a week; please, don't be impatient, don't hurry.

## INFORMATION PURSUANT TO ART. 13 GDPR FOR BENEFICIARIES AND EXTERNAL PEOPLE AND CONSENT TO PROCESSING

Dear Sir/Madam, pursuant to art. 13 and 14 of EU Regulation 2016/679 regarding the protection of personal data ("GDPR") we inform you of the following. Purpose of processing and legal basis. The Association will process the personal data concerning you or provided by you exclusively for the execution of your request or the service requested by you, the management of any contract/agreement or other relationship and for the fulfillment of the relevant legal obligations. The legal basis of the processing is represented by the contract (art. 6 paragraph 1 letter b GDPR) or by a legal obligation (art. 6 paragraph 1 letter c GDPR). Methods and principles of treatment. The processing will take place in compliance with the GDPR and Legislative Decree no. 196/03 ("Code regarding the protection of personal data"), as well as the principles of lawfulness, correctness and transparency, adequacy and relevance, with paper and electronic methods, by persons authorized by the Association and with the adoption of adequate protection measures, in order to guarantee the security and confidentiality of the data. No automated decision making will be carried out. Necessity of provision. The provision of data is necessary as it is strictly linked to the organization of the service and the management of the contract or relationship. Where the service consists in participation in events, courses or activities of the Association, your photographic images or videos may be acquired and published on the institutional website, in the social networks and in the printed information material of the Association, only with your explicit and separate consent. expressed. Communication and transfer of data abroad. The data may be communicated to the subjects responsible for carrying out the requested services and activities (e.g. external trainers) and the activities to which the Association is required by law (accountant, insurer, systems engineer, etc.). The data may be transferred to recipients based outside the EU who have signed agreements aimed at ensuring an adequate level of protection of personal data, or in any case after verifying that the recipient guarantees adequate protection measures. Where necessary or appropriate, the subjects to whom the data are transmitted for carrying out activities on behalf of the Association will be appointed as (external) data controllers pursuant to art. 28 GDPR. Data retention period.

The processing will have a duration no longer than that necessary for the purposes for which the data were collected (performance of the service or execution of the request), without prejudice to legal, accounting or tax obligations or the existence of legal protection needs of the Association, with the exclusion of communications to third parties and in any case applying the principles of proportionality and minimization. Rights of the interested party. As an interested party, you are guaranteed all the rights specified in the art. 15 - 20 GDPR, including the right to access, rectify and delete data, the right to limit and oppose processing, the right to revoke consent to processing (without prejudice to the lawfulness of processing based on consent acquired before revocation), as well as to lodge a complaint with the Guarantor for the Protection of Personal Data if you believe that the processing concerning you violates the GDPR or Italian legislation.
